Mayor's Report:

Reschedule the meeting that was cancelled with Minister Haggie . Mayor has had complaints regarding the hiring practices at Transmission Line (Vallard). The roads are in terrible shape and we as a Town need to contact them and advise they need to fix those roads.

Mayor has forwarded an email for application for green funding from Minister Judy Foote to Town Manager.

Mayor advised that he has had some discussions with a resident who had concerns with the cost of completing the proposed Town Hall – list of some of the main reasons why we need to have better working quarters:

- 1. There was mold contamination, and water infiltration in the basement of the old town hall office making it non workable.
- 2. The roofing on the Medical Building needed to be taken off and replaced we were advised by engineers that it was more feasible to replace it then fix it cost wise.
- 3. The office staff and other staff members would all be in the one office making it more cost effective as to having to heat several quarters and proving more efficient service.
- 4. Council has reviewed and re-reviewed the plan and has downsized as much as possible to lower costs.
- 5. This newer building will be more energy efficient and that in itself will be a cost savings.
- 6. We were fortunate enough to have signed the contract before the changes to the Municipal Affairs Capital Works Infrastructure Program change which will be on a 90/10% basis, where the province will pay 90%.
